Dear Pat:

I am outraged by the lack of progress made by the New York Power Authority in reversing management and safety problems at Indian Point 3. On New Year's Eve I learned that a meeting was held on December 10 between NRC regulators and Indian Point 3 administrators, at which time the regulators expressed strong concerns about the ability of personnel to handle the plant safely even when it is shut down, as it has been for 10 months. In an article reported in The New York Times, NRC regulators said that operators have such poor control over equipment that they could release radioactive or chemical materials into the Hudson River or make errors that will injure workers.

In fact, there have been major fiascoes this past year including one where workers released radioactive waste from the wrong tank into the Hudson. I have long believed that Indian Point 3 should be decommissioned before a terrible accident occurs. It is an aging plant, on the NRC's 'watch list' of the 10 worst in the nation, and it appears that its operators are unable to correct its deficiencies.

Please call for hearings in the Senate and urge our New York Congressional delegation to do the same in the House. In the meantime, please use your influence to see that a federal regulator is on site at all times to oversee all activities. This is a public safety issue of the greatest urgency which goes far beyond the boundaries of a single county. Thank you for your immediate attention to this matter.
