SUBJECT: INSPECTION REPORT NUMBER 50-286/94-13

This letter transmits the report of the announced inspection conducted by Mr. R. Paolino of this office from May 16-20, 1994, at the Indian Point 3 Nuclear Power Plant, located in Buchanan, New York, of activities authorized by NRC License DPR-64. At the conclusion of the inspection, the inspection findings were discussed with those members of your staff identified in the attached report.

The inspection was directed toward areas important to public health and safety. Areas examined during this inspection included NRC Restart Issue No. 2, "Resolving Emergency Diesel Generator Deficiencies." The inspection consisted of selective examinations of design records, procedures, representative records, interviews with Indian Point 3 personnel, and observations by the inspector.

Your corrective actions for resolving NRC Restart Issue No. 2 (Tasks 1 thru 9) were acceptable. This issue will be reviewed by the NRC NYPA assessment panel (NAP) for closure. Your scheduled completion dates for Indian Point 3 long-term action items were found to be acceptable.

In accordance with 10 CFR 2.790 of NRC's "Rules of Practice," a copy of this letter and its enclosure will be placed in the NRC Public Document Room.
