On February 16, 1997, the NRC completed an inspection at your Indian Point 3 reactor facility. The enclosed report presents the results of that inspection.

During the seven-week period covered by this inspection, you conducted activities at the Indian Point 3 reactor facility safely and conservatively. Your performance during this inspection period demonstrated the effectiveness of your organization in operating the plant and conducting maintenance during an extended forced outage. We considered the scope of work during the outage to be appropriate, the performance of certain surveillance tests to be conservative, and plant maneuvers to be well controlled.

Notwithstanding these improvements in overall performance, we noted continuing weaknesses in the work control process and the protective tagging process. Informality in these processes was indicated by procedural non-compliances regarding the release of work and other work control aspects, the lack of procedural guidance associated with the operations/work control feedback process, and the lack of corrective actions in response to the feedback from the field support supervisors. This is of particular concern to us because of the recurrence of work control and protective tagout problems, as documented in previous NRC inspection reports. The procedure non-compliances and the lack of corrective actions to feedback from the field support supervisors constituted violations of NRC requirements. Separately, a violation was identified for failing to install a radiation monitoring system in the new fuel storage areas capable of alarming should accidental criticality occur.

These violations are cited in the enclosed Notice of Violation, and the circumstances surrounding the violations are described in detail in the enclosed report. Please note that you are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response. The NRC will use your response, in part, to determine whether further enforcement action is necessary to ensure compliance with regulatory requirements.
