Dear Mr. Neuhaus:

This refers to your letter dated November 30, 2009, requesting changes to your license, including change in your mailing address. Please note that the first two digits of an NRC license identify the State of the licensee's mailing address, therefore when a licensee changes its mailing address to another State, a new license with a new number (corresponding to the State of the new mailing address) must be issued to replace the existing license. Your mailing address was in the State of Tennessee, and you requested to change it to a new address in the State of North Carolina; therefore, it was necessary to administratively terminate your license with mailing address in the State of Tennessee, and concurrently issue a new license with address in the State of North Carolina. **The conditions of your license and your commitments remain unchanged and are incorporated into the new license.**

Enclosed with this letter are the new license (No. 32-31395-01) and the terminated license (No. 41-25460-01). Please note that item 8 of the new license specifies the maximum possession limit of each radioisotope authorized on the license. These limits are specified in accordance with your telephone conversation of January 21, 2010, with Mr. Randolph C. Ragland, Jr., of this office. You are required to request and receive amendment to your license **prior** to bringing licensed material in NRC jurisdiction, in excess of these limits. Additionally, Condition 18 that appears on your previous license is not included in the new license because it is no longer applicable.

Please review the enclosed documents carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
