### MINUTES FROM NAP MEETING 93-08

NAP meeting 93-08 began at 1:30 PM on May 20, 1993. Pete Eselgroth opened the meeting by reviewing the previous meeting minutes and the open NAP Action Items. There were no additions or corrections to the 93-07 NAP meeting minutes. NAP Action Item 93-05-04 was closed; the revised NAP charter was issued on May 13, 1993. NAP Action Item 93-06-03 was closed; Bill Cook inspected the QA oversight/classification of maintenance activities at Indian Point 3. He concluded that the circumstances surrounding the AMSAC system was an isolated case and that this QA concern need not be made a generic restart issue for other systems. The NAP agreed with his recommendation. NAP Action Item 93-07-01 was closed; the restart issues subcommittee incorporated NAP member comments and revised the Draft Restart Issues List. NAP Action Item 93-07-03 was closed; Glenn Tracy communicated the current restart issues to NYPA through discussions with the Resident Manager, John Garrity. NAP Action Item 93-07-04 was closed; NAP member comments were incorporated into the Restart Action Plan. Enclosure 1 contains the NAP Action Item List.

Bill Cook discussed the current plant status at FitzPatrick. The plant shut down on May 19, 1993, to repair the HPCI system discharge check valve, which had a body to bonnet leak past the pressure seal. While shutdown, the licensee plans to work some priority 1 work requests and address NRC Bulletin 93-02. FitzPatrick is sending four department managers to Indian Point 3 to assist them with their Performance Improvement Outage during the weeks of May 24 and 31, 1993. Brian McCabe informed the NAP that a letter from NRR would be issued shortly seeking information on FP60, a type of fire barrier material used at various nuclear power plants. The latest INPO plant evaluation rated NYPA a Category 3 with two areas of concern. The first area involved the high number of changes issued to field modifications due to installation problems and technical errors. The second concern focused on non-licensed individuals being qualified to perform certain duties without receiving proper training.

Glenn Tracy reported the current plant status at Indian Point 3. Work on the reactor coolant pumps and their associated motor coolers is continuing. Work on various other equipment is continuing such as the condensate storage tank and primary water storage tank bladders, overhaul of the #31 auxiliary boiler feed pump, and preparations for overhaul of the #33 diesel generator.

Pete Eselgroth briefly reviewed the preliminary findings of the Special Team Inspection. Once the findings are finalized by the Team, the NAP will review them for addition to the Draft Restart Issues List.

Nick Conicella briefly highlighted the changes to the Draft Restart Issues List. A major change was the addition of actions associated with NRC Bulletin 93-02. Nick Conicella also discussed the Restart Action Plan. In response to concerns raised by members of the NAP, Pete Eselgroth was assigned NAP Action Item 93-08-01, to resolve how the NAP will apply the restart process checklist from Manual Chapter 0350.

The final area for discussion was inspection support at Indian Point 3. Glenn Tracy requested specialist inspection support from resources outside the resident staff. Lee Bettenhausen was assigned NAP Action Item 93-08-02 to propose assistance from DRS. The areas involved were AMSAC, fire protection/Appendix R, cable separation, orifice plates, fuse control, EDSFI followup, jacketed cable, seismic batteries, submerged cable, Bulletin 93-02, instrument bus voltage, and surveillance tests from last the refueling outage. Curt Cowgill questioned whether NYPA should verify and validate the Indian Point 3 surveillance test database and provide their results to the NRC; the NAP assigned Glenn Tracy NAP Action Item 93-08-03 to provide a recommendation at the next panel meeting. The NAP assigned Curt Cowgill NAP Action Item 93-08-04 to determine if another temporary resident inspector position should be assigned to IP3 once the current temporary position vacates in July.

The meeting adjourned at 3:30 PM.
