Dear Mr. Grimes:

Your November 15, 1978 letter transmitted Revision 1 of the Draft Radiological Effluent Technical Specifications and a copy of NUREG-0133, "Preparation of Radiological Effluent Technical Specifications for Nuclear Power Plants" for use in preparing a license amendment application to incorporate applicable portions of the model Radiological Effluent Technical Specifications into Appendix "A" Technical Specifications. A revised submittal schedule was included with this transmittal.

This material was not received by Con Edison until January 2, 1979. Our review to date has led us to believe that we currently comply with the regulatory requirements addressed in your November 15, 1978 letter. However, because of the extensive revisions to the Draft Technical Specifications and the fact that NUREG-0133 had not been previously distributed to us, we need additional time to complete our review and formulate our response. Accordingly, we anticipate that our reply to this submittal request will be forthcoming by April 16, 1979. We hereby request an extension of time until this date for responding to this submittal request.
