SUBJECT: SUMMARY OF JANUARY 28, 2010, CATEGORY 2 MEETING
REGARDING THE NATIONAL FIRE PROTECTION ASSOCIATION
STANDARD 805 FREQUENTLY ASKED QUESTION PROCESS

On January 28, 2010, the U.S. Nuclear Regulatory Commission (NRC) staff held a meeting, via teleconferencing, with stakeholders and the public to discuss Frequently Asked Questions (FAQs) at plants that are adopting National Fire Protection Association (NFPA) Standard 805. Licensees presented comments related to the NRC draft interim position on a FAQ (08-0051) related to NUREG/CR-6850. Licensees and the NRC staff discussed the remaining currently open FAQs. The participants determined that both industry stakeholders and the NRC staff needed to continue to work on the remaining open FAQs.

NRC staff presented updated schedules for the review of the pilot plants' license amendment requests and development of NFPA 805 infrastructure.

Participants agreed that the next FAQ meeting would take place on February 25, 2010, via teleconferencing. Future meeting dates were tentatively set for March 18, 2010 and April 22, 2010.
