**LICENSEE:**



Non-Cited Violation(s) was/were discussed involving the following requirement(s) and Corrective Action(s):

*10 CFR 35.63(d) requires that, unless otherwise directed by the authorized user, a licensee may not use a dosage if the dosage does not fall within the prescribed dosage range. Contrary to this requirement, on several occasions from March 31 - December 15, 2009, including 3/31, 4/7, 5/12, 11/11, 12/14 and 12/15/09, the licensee administered dosages that did not fall within the dosage range prescribed by the authorized user. The licensee has committed that effectively immediately on Jan 27, 2010, no dosages will be used unless they are within the prescribed dosage range or have approved in advance by an Authorized User.*

I hereby state that, within 30 days, the actions described by me to the inspector will be taken to correct the violations identified.
