reference 2. These pages were reconciled with the most current amended  
Technical Specifications by Reference 3.

The purpose of this letter is to transmit a further revised Technical  
Specification Table 4.1-1 page 4 of 7. This page corrects a footnote for  
Item 28. This footnote contains two temperature values. Earlier  
submittals (References 1 and 3) revised only one temperature value for  
this footnote instead of both.
