The licensee provided a response to the RAI on August 15, 2008 (ADAMS Accession No. ML082340846), which included detailed descriptions of the administrative and managerial controls to deter and address inattentiveness and complicity among licensee security personnel at BVPS-1 and 2. The NRC staff has reviewed the submitted information and has concluded that the responses to Bulletin 2007-01 and related RAI are adequate for BVPS-1 and 2. The bases for the NRC's conclusion have been documented in a memorandum, "Security Bulletin 2007-01, Security Officer Attentiveness: Summary Report" (ADAMS Accession No. ML093440311). Based on this review, Bulletin 2007-01 will be closed and no further action is required.
