As you know, I conducted an inspection at Cintichem on April 29, 1993. Although I informed you at the exit interview that no violations were found, I failed to so inform you in writing. Please accept my apology for that omission.

This letter reports the results of my April 29, 1993 inspection of operations in Building 4 at Cintichem. The inspection was conducted pursuant to 6 NYCRR Part 380, Rules and Regulations for the Prevention and Control of Environmental Pollution by Radioactive Material. Cintichem has been operating under Order on Consent No. D200059005, which authorizes the emission of radioactive material to air from emission point 2B.

The inspection was an examination of activities conducted in Building 4, and those authorized under the Order on Consent, to assess their compliance with Part 380 and the Order on Consent. The inspection consisted of observations of equipment, interviews with personnel, and a selective examination of representative records.

The preliminary findings of the inspection were discussed with you and Mr. Truskowski at the close of the inspection. Within the scope of this inspection, operations in Building 4 at Cintichem were found to be in compliance with Part 380 and the terms of the Order on Consent.
