Scope:

The areas examined during this routine material control and accounting (MC&A) safeguards inspection included facility organization and management controls, measurement control and statistics, physical inventory,

and various MC&A related records and reports.

Additional discussions and observations pertaining to

#### 2. Facility Organization and Management Controls (85203)

The inspection included review of the licensee's current management structure and training and qualification program. The licensee's organization chart dated November 14, 1990, was updated while the inspector was on site. The licensee failed to report four new appointments to reflect current MC&A assignments as of April 17, 1991. In addition, the licensee has not implemented the certification program for two of these new appointees. These program inadequacies are summarized in Enclosure 3. The licensee's failure to meet these objectives and commitments has not decreased significantly the effectiveness of the safeguards program, however it does reflect a weakness in the administrative practices.

#### 3. Measurement Control and Statistics (85209)

Calibration data and control charts for standard measurements were reviewed. Limited activities on measurement have been performed because of the circumstance of plant shutdown. The licensee's measurement control program was found to be sufficient.

#### 4. Physical Inventory (85211) & Records and Reports (85215)

Reconciled values reported on NRC Form 327 for the March 5, 1991, and January 4, 1991, physical inventories were traced to the original documents and calculations were confirmed. The inventory differences (ID's) were within regulatory limits.

# 5. Followup on Inspector Identified Problems and Unresolved Items (92701)

(Closed) Inspector Followup Item No. 90-202-01. Annual review and audit of Physical Inventory results and the Measurement Quality Assurance Manual have been completed by the Measurement Control Coordinator. This item is closed.

(Closed) Inspector Followup Item No. 90-202-02. Routine practices for logging all standard measurements for documentation and verification of control chart data have been implemented by the licensee. This item is closed.

#### 6. <u>Exit Meeting</u> (30703)

The inspection scope and findings were summarized during a meeting on April 19, 1991, with the licensee personnel identified in paragraph 1 above. Two followup items resulting from a previous inspection, as noted in paragraph 5 above, were closed. No exceptions were expressed by the licensee in regard to the two non-cited violations identified in Enclosure 3.

The inspection determined that the overall effectiveness of the licensee's MC&A safeguards program had not been significantly affected due to the non-cited violations.

#### NON-CITED VIOLATIONS (NCV)

#### NCV No. 91-201-01:

The licensee's organization chart was updated on April 17, 1991. There were four new changes in MC&A assignments: Manager Health, Safety and Environmental Affairs, Q.C. and Analytical Services Manager, Q.C. Supervisor, and Measurement Control Coordinator. Cintichem failed to notify the NRC of these changes to the Fundamental Nuclear Material Control (FNMC) Plan in compliance with the requirements of 10 CFR 70.32(c)(2)(i).

#### NCV No. 91-201-02:

Training and qualification were not implemented for two new appointees to FNMC Plan responsibilities: Manager Health, Safety and Environmental Affairs, and Q.C. and Analytical Services Manager. This was contrary to the training program as described in Section 1.3 of the FNMC Plan and the requirements of 10 CFR 70.57(b)(7).
