In response, "Need for Power" is addressed in Chapter 8 of the environmental impact statement. If the PSC order results in new and significant information relevant to PEF's Environmental Report or the NRC's EIS, that information would then need to be provided to the NRC under oath and affirmation.

I received letters NPD-NRC-2010-008, 009 and 011 last week. Neither the letters or attachments provided information on the effects of operational pumping on wetlands or a clarification on the ratings for the alternative sites. Please provide a date on when the NRC staff can expect this information.
