Dale,

When we met in July I indicated I would send you docket numbers for information related to GE-Hitachi's proposed uranium enrichment facility and for the neighboring Global Nuclear Fuels -- Americas (GNF-A) facility. I also indicated I would send you the most recent environmental report supplement for GNF-A.

I am sorry for the delay in my reply. The docket number for the proposed uranium enrichment facility is 07007016. The docket number for GNF-A is 07001113. When we spoke you indicated you were familiar with ADAMS. If you put these numbers into the "docket" field of ADAMS, you will get all of the files related to the project.

The most recent supplement to the environmental report for GNF-A is a large file and our email system is having trouble with it. Because you are familiar with ADAMS, please note that you can get the file by putting the code ML071000137 into the "accession number" field in ADAMS. Please let me know if you have trouble locating the file and I will try again to send it to you. We do not yet have an environmental report for the proposed enrichment facility because GEH has not submitted a license application or environmental report yet.
