


The purpose of this modification is to remove Optional Task E in the amount of \$25,520.

Accordingly, the following changes are hereby made:

1. Section B. CONSIDERATION AND OBLIGATION—COST PLUS FIXED FEE (JUN 1988), paragraph (a) is hereby deleted in its entirety and replaced with the following:
