SUBJECT: REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE
(MFN 09-787, SUPPLEMENT 3)

Dear Mr. Head:

By letter dated February 25, 2010, and associated affidavit executed on February 25, 2010, by Larry J. Tucker, Mr. Tucker indicated that the information contained in "Supplemental Response to Portion of NRC RAI Letter Nos. 369 and 386 Related to ESBWR Design Certification Application – DCD Tier 2 Section 3.6 – Protection Against Dynamic Effects Associated with the Postulated Rupture of Piping; RAI Numbers 3.6-6 S04 Part B and 3.6-24," should be withheld as proprietary. GE-Hitachi Nuclear Energy (GEH) requested that this information be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Section 2.390.

GEH has requested that the information be withheld in its entirety, therefore a nonproprietary copy is not available.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

1. The information discloses a process, method, or apparatus, including supporting data and analyses, where prevention of its use by GEH's competitors without license from GEH constitutes a competitive economic advantage over other companies; and
2. The information which, if used by a competitor, would reduce his expenditure of resources or improve his competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing of a similar product.

We have reviewed the February 25, 2010, letter and affidavit in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements contained therein, have determined that the information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure. Therefore, the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.
