Mr. Thielmann's Response:

Mr Thielmann agreed and indicated that he should be able to submit the response by 01/20/2010.

He also indicated that initially he was going submit the NRC Form 313 but when he contacted the NRC (he did not name anyone specifically) about questions he had about the Form 313 that we told him that it would not be necessary and only a letter requesting the renewal of the license would be sufficient.

I informed Mr. Thielmann that we reserve the right to request a complete application so that I know that he has looked at those (NUREG 1556, Vol. 1, Rev. 1, Appendix B) aspects of their program and can/will comply with them.

Again, he agreed and should be able to submit response by 01/20/2010.
