Travis E. Stills, counsel for Oglala Sioux Tribe in the above captioned matter, now submits the attached sworn and signed copy of the Non-Disclosure Affidavit, as is required by the March 5, 2010 *Memorandum And Order*.

Undersigned Counsel respectfully submits that good cause exists for filing the affidavit beyond the three day period set forth in the *Memorandum and Order*. First, on March 1, 2010, the harddrive crashed on the computer which contains the Digital ID Certificate, preventing Counsel for signing up for service through the Electronic Information Exchange (“EIE”). Second, the computer was in the possession of a computer technician through March 5, 2010 for installation of a new harddrive and associated software. However, the computer failed again on March 8, 2010 and remains with the technician. A new computer was purchased on March 11, 2010 which will serve as a secure computer from which Counsel will gain the necessary certificates and permissions to send and receive EIE filings.
