


- The purpose of this modification is to:
- Extend the period of performance from 9/15/2009 - 3/14/2010 to 9/15/2009 - 5/14/2010;
  - Increase the task order ceiling by \$57,339.00 from \$163,008.00 to \$220,347.00
  - Add funding in the amount of \$30,000.00.

As a result of adding funding, the total obligated amount for this task order is increased by \$30,000.00 from \$163,008.00 to \$193,008.00. The current ceiling amount is \$220,347.00. The remain ceiling of \$27,339.00 is unfunded. The Contractor cannot exceed the currently obligate amount. If the Contractor exceeds the stated amount, the Contractor does so at it's own risk.
