Dear Mr. Sawyer:

This letter is in reference to your electronic response dated February 12, 2002, and received today, responding to our request for additional information dated January 24, 2002. As previously discussed, during our review of your renewal request, we identified some discrepancies in information contained in your License No. 20-15285-03E, your Registration Certificate NR-0668-D-101-E and your renewal application dated August 22, 2001. We understand that your review of these documents did not reveal any changes made to the products since the last registration certificate amendment dated April 27, 1992. However, we still have some questions related to apparent inconsistencies among the three documents. Please respond to the following :

- Do the Models CPD-702X & 704X contain dual ion chambers? If so, then please request that the activity on the license and the registration certificate be increased (1.5 x 2 = 3 uCi or 2.5 x 2 = 5 uCi).
- 2) Is the Model CPD-705X a dual chamber device (0.6 x 2 = 1.2 uCi)?
- 3) Has the Model CPD-705X been manufactured other then in Japan? If so, please request an amendment to the registry certificate (NR-0668-D-101-E, 4/27/92)
- 4) What device uses the 0.6 uCi ion chamber and what device uses the 2.5 uCi ion chamber as indicated in the 8/22/01, renewal application?

If there are changes, please submit sufficient information for these changes to be reviewed by the NRC.

Please send the information within 30 days of the date of this letter. If we do not receive a response from you, we will consider your request for the license renewal as having been abandoned and void the active control for your renewal request. This would require you to suspend distribution of the licensed devices and would require NRC to start proceedings to deny the renewal.
