Subject: Request For Clarification of Confidential Information Marking on Drawing No. 06-117926-001, Included With Letter Dated 5/23/02, For US NRC License No. 20-15285-03E, Amendment No. 04

Dear Mr. Sawyer:

We are in the process of making available the documents from the review of your application for amendment dated March 23, 2002. As indicated in our electronic mail to you dated April 15, 2003, one of the drawings you submitted was marked confidential. You indicated in your reply that you would look into this. Since we have not received a response to date, if we have not received complete information within thirty days of the date of this letter, we will make your entire application publically available as is customary.

As a reminder, Drawing No. 06-117926-001, included with a letter dated 5/23/02, has a confidential notice. If you do not intend for this document to remain confidential, please provide a waiver regarding the proprietary nature of this drawing, submit a drawing with the confidential items eliminated or, if you wish to maintain the proprietary classification, you may request that certain portions of your submittal to NRC be withheld from public disclosure as proprietary information. To do this, you must execute an affidavit as specified in 10 CFR 2.790, which must be reviewed and approved by our legal office. You must list all portions that you wish to be held proprietary, along with your reasoning as to why that is appropriate. For each document or page, please submit two copies. One copy should be an unmarked copy containing all information. The second copy should have removed from it, all information that you wish to be held proprietary. This second copy will be placed in the NRC's public document room. While it is allowable, please refrain from submitting proprietary information in support of a registration or license unless necessary. Keep in mind that all registration certificates in the Sealed Source and Device Registry, and all NRC licenses are considered to be in the public domain, and therefore may be viewed by any member of the public who requests to see them.

Please submit the requested information within thirty days of the date of this letter. If we have not received complete information within thirty days of the date of this letter, we will make your entire application publically available as is our usual procedure.
