Current Status:

- NRC Staff has received 94 submissions with 687 individual comments
- December 8, 2009 Commission briefing
- Notable issues occupying our attention



Proposed EP Rulemaking and Guidance

Remaining Milestones:

- Complete Draft Final Rule & NRC Guidance
- Coordination with FEMA
- ACRS Review
- Submit Final Rule to Commission
- Publish Final Rule & Guidance



Revision to Supplement 3 of NUREG-0654 / FEMA-REP-1

- Draft Supp 3 has been coordinated with FEMA
- Published in the Federal Register for public comment
 - 75 day comment period
- Expect to resolve comments and issue with final EP rule
