The purpose of this modification is to: 1. Change the period of performance from 5/1/2009-4/30/2010 to 5/1/2009-9/30/2010  
2. Option Period 2 is deleted; 3. Decrease the task order ceiling by \$217,600.00 from \$790,156.43 to \$572,556.43;  
4. Add funding in the amount of \$39,523.00.


As a result of adding funding, the total obligated amount for this task order is increased by \$39,523.00 from \$250,101.61 to \$289,624.61. The current ceiling amount is \$572,556.43. The remaining available ceiling is \$282,931.82. The Contractor cannot exceed the currently obligate amount. If the Contractor exceeds the stated obligated amount, the Contractor does so at it's own risk.

All other terms and conditions remain unchanged.


