| Purpose of Meeting:       | The purpose of the meeting is for Entergy to discuss the results of safety culture workplace surveys conducted in 2009 at its Fitzpatrick, Indian Point Units 2 and 3, Pilgrim and Vermont Yankee nuclear facilities. This meeting has been scheduled in accordance with a commitment made by Entergy to meet with the NRC Regional Administrators in Regions I, III, and IV and provide this information, as part of a commitment confirmed in an NRC Confirmatory Order (CO) [ML0932105623], dated November 10, 2009. This commitment was made by Entergy as part of an Alternate Dispute Resolution agreement reached with the NRC concerning an issue at the Palisades Nuclear facility in Michigan. |  |  |
