This refers to your request dated January 19, 2010, for termination of your above listed licenses. Your facilities in Delaware and Connecticut were added to your NRC license No. 29-30465-01 in accordance with your letter dated September 10, 2009. We did not terminate the above licenses at that time because your letter did not specifically request concurrent termination of the above licenses.

Please find enclosed Amendment No. 04 terminating License No. 07-30467-01 and Amendment No. 06 terminating License No. 06-30466-01, as requested by your letter dated January 19, 2010. These licenses are being terminated in accordance with the requirements of the applicable NRC License Termination Rule (10 CFR 30.36). All facilities previously used for licensed activities under NRC License Nos. 07-30467-01 and 06-30466-01 may be released for unrestricted use. However, these facilities, located at 1279 McDaniels Drive, Dover, Delaware and 35A North Plains Industrial Road, Wallingford, Connecticut, remain authorized use and storage locations as specified in NRC License No. 29-30465-01.
