This shipment consists of 16 x 48Y Cylinders loaded on 16 x 20' flatracks. RADIOACTIVE MATERIAL, URANIUM HEXAFLUORIDE, non fissile or fissile-excepted. Total net weight of U is 131,578 kgs. The net weight of U-235 is 933 kgs.

3) Transportation and Route Schedule

The surface transportation from Metropolis, IL to Paducah, KY will be the responsibility of TAM International Inc. The US inland transportation from Paducah, KY to Portsmouth, VA will be the responsibility of R & R Trucking. The ocean transportation from Portsmouth, VA to Antwerp, Belgium will be the responsibility of Atlantic Container Line. Export from the United States will occur at Portsmouth, VA on or about January 10, 2010.
