Public Phone Conference with Salem

On Tuesday, March 16, 2010, staff held a public phone conference with the licensee for Salem to discuss the licensee's planned responses to an NRC staff request for additional information regarding Generic Letter 2004-02, Pressurized Water Reactor Sump Performance.

Public Phone Conference with Point Beach

On Wednesday, March 17, 2010, staff held a public phone conference with the licensee for Point Beach to discuss the licensee's planned responses to an NRC staff request for additional information regarding Generic Letter 2004-02, Pressurized Water Reactor Sump Performance.

Public Meeting on National Fire Protection Association Standard 805 (NFPA 805)

On Wednesday, March 17, 2010, staff held a Category 3 public meeting with external stakeholders and interested members of the public to discuss template guidance for nuclear plants transitioning to NFPA 805. The staff provided preliminary feedback to the Nuclear Energy Institute on certain sections of the NFPA 805 License Amendment Request Template and shared a draft section of the NFPA 805 Safety Evaluation Template.

Fire Protection Meeting on NFPA 805 Frequently Asked Questions (FAQs)

On Thursday, March 18, 2010, the staff held a Category 2 public meeting with the Nuclear Energy Institute NFPA 805 Task Force and other stakeholders to discuss the FAQs related to licensees' adoption of NFPA 805. The staff began holding these monthly public meetings in July of 2006 and expects to continue to hold them at least throughout the transition period for the pilot plants adopting NFPA 805.

Publication of Draft Regulatory Guide 8040 (DG-8040), "Health Physics Surveys During Enriched Uranium-235 Processing and Fuel Fabrication"

On March 18, 2010, RES staff issued DG-8040 to provide an opportunity for public comments. The draft guide is proposed Revision 2 to Regulatory Guide 8.24 that specifies the types and frequencies of surveys acceptable to the NRC for the protection of workers in plants licensed by NRC to process enriched uranium and fabricate uranium fuel. Withdrawal of Regulatory Guide (RG) 8.6, "Standard Test Procedures for Geiger-Müller Counters"

On March 17, 2010, the RES staff published a *Federal Register* Notice announcing the withdrawal of RG 8.6 titled, "Standard Test Procedures for Geiger-Müller Counters." The RG endorsed test procedures specified in ANSI N42.3-1969, "Test Procedure for Geiger-Müller Counters." NRC is withdrawing RG 8.6 because ANSI N42.3-1969 has not been revised and is outdated and no longer useful.

Revision of Fee Schedules; Fee Recovery for FY 2010; 10 CFR Parts 170 and 171 (RIN A170, NRC-2009-0333)

On March 10, 2010, the NRC published a proposed rule (75 FR 11375) in the *Federal Register* to amend the licensing, inspection, and annual fees charged to its applicants and licensees. The proposed amendments are necessary to implement the Omnibus Budget Reconciliation Act of 1990 (OBRA-90), as amended, which requires the NRC to recover, through fees, approximately 90 percent of its budget authority in fiscal year (FY) 2010, not including amounts appropriated from the Nuclear Waste Fund, amounts appropriated for Waste Incidental to Reprocessing, and amounts appropriated for generic homeland security activities. Based on the Energy and Water Development and Related Agencies Appropriation Act, 2010, signed by the President on October 28, 2009, the NRC's required fee recovery amount for the FY 2010 budget is approximately \$912.2 million. After accounting for billing adjustments, the total amount to be billed as fees is approximately \$911.1 million. The comment period for this action expires April 9, 2010. Because OBRA-90 requires that the NRC collect the FY 2010 fees by September 30, 2010, requests for extension of the comment period will not be granted.

National Archives Meetings

On March 2, 2010, OIS staff attended meetings hosted by the National Archives and Records Administration (NARA). The first meeting held by the Federal Records Center Program Forum discussed the proposed rule on fees associated with the maintenance of Official Personnel Files. The second meeting, the Bimonthly Records and Information Discussion Group, covered the results of the FY 2009 Records Management Self-Assessment and expectations for the Electronic Records Reporting mandate. In addition, OIS staff will be participating in a focus meeting to help determine topics and speakers for NARA's upcoming conference titled "Managing the Records of an Open Government."

Digital Government Institute Conference

On March 4, 2010, OIS and Office of General Counsel staff attended the *E-Discovery, Records & Information Management Conference & Expo* sponsored by the Digital Government Institute which had more than 350 verified attendees. The keynote speaker, from the National Archives and Records Administration, discussed "Is Freedom of Information in the Digital Age a Contradiction in Terms?" OIS staff participated in a panel session entitled "Influencing Change within Agencies--Practical Recommendations for 2011." This session brought together perspectives from experts and experienced practitioners who shared how they are modernizing their records and information management programs.

Presentation on Outcome-Based Information Management

On March 11, 2009, OIS staff attended a meeting of the Metro Maryland Chapter of ARMA International (formerly the Association of Records Managers and Administrators). The presentation focused on learning how to craft an outcome-based information management program instead of an "activity-based" program. By examining real use cases from the Department of Homeland Security, the Department of Defense and other agencies, critical factors necessary for successful information management were identified such as how to work backwards from outcomes to activities to resources in order to effectively plan a program roadmap. In addition, the presenter discussed how to focus and accelerate information management processes for greater efficiency and efficacy in achieving business outcomes.
