
14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible)

The purpose of this modification is:

1. Provide incremental funding in the amount of \$45,000.00.
 2. Correct the current contract ceiling from Modification #11.
 3. Revise Section B.3 Consideration and Obligation - Delivery Orders of the contract.

The current period of performance shall expire on 9/26/2010 with one additional option year to exercise. The current contract ceiling shall remain unchanged at \$706,800.00 and the total contract ceiling shall remain unchanged at \$893,000.00.

Contract NRC-37-06-351 is hereby modified as follows:

1. Incremental funding in the amount of \$45,000.00 is hereby obligated. Funds are increased by \$45,000.00 from \$270,000.00 to \$315,000.00.
2. The contract ceiling, described in Modification #11 for Option Year #3, is hereby revised from \$520,600.00 to \$706,800.00, which is the correct contract ceiling through Option Year #3. The total contract ceiling shall remain unchanged at \$893,000.00.
