SUMMARY

We have reviewed your letter dated December 21, 2009, requesting an amendment to your byproduct materials license. We find that we need additional information as follows:

Please resubmit your application for an amendment in its entirety, focusing on the responses and commitments in Appendix B in NUREG-1556, Vol. 4, dated October 1998.

1. **You requested that we amend your license by adding Ra-226 calibration source and then subsequently provided the serial number for that source. This information is insufficient for us to process this amendment request. Please provide the source or device's manufacturer name and model number. The manufacturer's name and model number should match the Sealed Source Device Registry for the material that you are requesting to be added to your license.**
2. **We now require a total possession limit for each radionuclide requested, as well as providing the "per source" activity you need, which should match the Sealed Source and Device Registry certificate procured by the vendor. Please provide this information, and it is acceptable to request more sealed sources than you may actually need immediately, to allow for some growth, so long as the request is reasonable and realistic.**

We will be unable to continue processing your request until we receive this information.


ACTION REQUIRED
