This RAI also addresses the "Calvert Cliffs Nuclear Power Plant, Unit 3, Security Plan, Training and Qualification Plan, Safeguards Contingency Plan," Revision 3 and "Calvert Cliffs Nuclear Power Plant, Unit 3, Security Assessment, Revision 4," as submitted in Part 8 of the CCNPP Unit 3 COLA.

Responses to RAI No. 189, Questions 13.06-2, 13.06-3 and 13.06-4 were provided in letter UN#09-499, dated December 8, 2009 (Reference 2) along with a schedule for the response for the remaining RAI Questions, 13.06-1 and 13.06-5 through 13.06-85, by March 23, 2010. Responses to RAI No. 189, Questions 13.06-1, and 13.06-5 through 13.06-85 were provided in letter UN#10-070, dated March 23, 2010 (Reference 3). The Enclosure to this submittal provides the revisions to the Security Plan that include SGI material.

Our responses do not include any new regulatory commitments. The enclosure to this letter does contain Safeguards Information and is forwarded under Safeguards Information Controls.
