This letter is a request for an amendment to the Radioactive Materials License 21-00265-06 of The Dow Chemical Company, Midland, Michigan.

Please change the Radiation Safety Committee Chairperson for this license from Brad Fedorchak to Dan Rader. Mr. Rader is assuming the responsibilities of the Site Responsible Care Leader for the Dow Michigan Operations site from Mr. Fedorchak and will be taking the responsibilities of Radiation Safety Committee Chairperson.

Mr. Rader has extensive leadership experience, with a combined 24 years of experience at Dow Chemical, including Production Leadership and Project Management roles in Manufacturing and Engineering as well as roles in EH&S and Quality Performance. From 2000 until 2006, he served as President of DHCompounding, a previous 50/50 joint venture between Dow and PolyOne Corporation. His most recent assignment was as Director of Dow's EH&S Safety Expertise Centers, which included responsibility for the Industrial Hygiene, Personal Safety, EH&S Systems Services, EH&S Learning/Training and Improvement Expertise Centers.

Mr. Rader is not a technical expert in the field of radiation safety and has little direct experience in working with radioactive material. However, his knowledge in the fields of chemical safety, personal safety, process safety, and environmental safety gives him a strong background in risk management. The site Radiation Safety Officer will advise the Chair on technical issues, as necessary, to ensure that the Chair is able to appropriately direct the Committee.

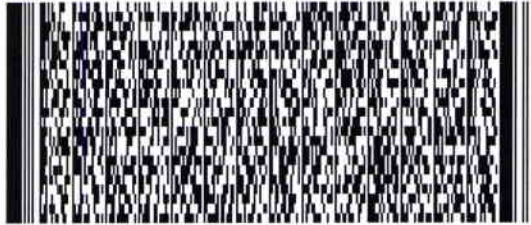

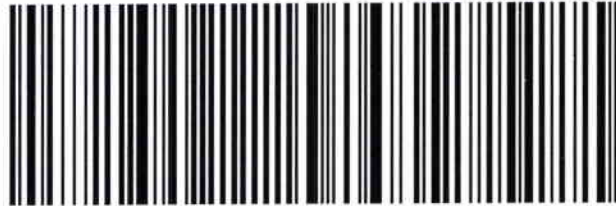
