The licensee reported that further schedule delays have occurred due to increase in the work scope and the availability of the resources. Also, based on the published schedule for the second NFPA 805 Pilot Plant (Oconee) safety evaluation, the licensee has also changed the final completion date for the project from September 30, 2010, to December 31, 2010.
