RAI-SRP 6.1.2-CIB1-01 - AP1000 Service Level II coatings

Please explain how the AP1000 DCD ensures COL applicants address the quality program for Service Level II coatings in containment. If necessary, provide a draft DCD revision. DCD subsection 6.1.2.1.6 states that Appendix B to 10 CFR Part 50 applies to procurement of Service Level II coatings in containment (except for a chemical and volume control system room). It also states that the program for Service Level II coatings is addressed in DCD subsection 6.1.3.2. However, subsection 6.1.3.2 requires COL applicants to provide a coating program only for Service Level I and Service Level III coatings. Therefore, it is not clear to the staff how the intent of the DCD is transformed into action by COL applicants for Service Level II coatings in containment.
