The purpose of this modification is as follows:

- (1) To exercise the first option year under the subject contract in accordance with FAR Clause 52.217-9 – Option to Extend the Term of the Contract. As a result, the ceiling amount and the obligated amount of the subject contract is increased by \$73,800, from \$580,300 to \$654,100. By exercising the first option year, the period of performance of the contract is extended through April 2, 2011.

Accordingly, the following section(s) of the contract is hereby modified:

- (1). Paragraphs (1) and (2) under Section B.2, CONTRACT AMOUNT, are deleted in their entirety and replaced with the following (changes highlighted in red):
