SUBJECT: VOGTLE ELECTRIC GENERATING PLANT UNITS 3 AND 4  
COMBINED LICENSE APPLICATION - ADVANCED SAFETY  
EVALUATION WITHOUT OPEN ITEMS FOR CHAPTER 15,  
“ACCIDENT ANALYSIS”

By letter dated March 28, 2008 (ML081050133), Southern Nuclear Operating Company (SNC) submitted an application to the U.S. Nuclear Regulatory Commission (NRC) for a combined license (COL) for Vogtle Electric Generating Plant (VEGP), Units 3 and 4.

Based on our review of the application, the staff is providing the Advisory Committee on Reactor Safeguards (ACRS) its Advanced Safety Evaluation (ASE), without open items for Chapter 15, “Accident Analysis” (ML100130006). Unless otherwise stated in the ASE, the staff’s review was based on Revision 2 of the application. The ASE is being provided to support a meeting of the subcommittee of the ACRS scheduled for December 2010. The ACRS Full Committee meeting will be held after the subcommittee.

The staff has reviewed the ASE and found no topics that meet the categories of interest that ACRS members would like to review in detail.

Therefore, the staff requests that the ACRS withhold the ASE from public disclosure until it has been released publicly in the Agencywide Documents Access and Management System.

The staff will inform the ACRS immediately if SNC requests that any of the information in the ASE be withheld from public disclosure.
