Dear Mr. Burnett:

This refers to the letter dated December 11, 2009, and the application dated December 11, 2009, informing the NRC of the transfer of ownership and control of NRC Byproduct Material License No. 13-00772-02. Based upon our review of this correspondence, the NRC consents to the change of ownership transaction as stated.

Enclosed is Amendment No. 74 to your NRC Material License No. 13-00772-02 in accordance with your request. Please note that the changes made to your license are printed in **bold** font.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

In the course of our review, it appears that your attorney, Anthony C. Sullivan, signed the letter dated December 11, 2009, submitted on your behalf. This is not an acceptable signature as the NRC license is issued to senior management, who must sign all correspondence to us.

**Please note that we can only accept such signatures if a senior licensee management representative, such as James T. Jobe, Vice President, either co-signs the letter or refers us to a “non-licensee signatory” as a “point of contact” via management-signed correspondence.**

**In addition, we noted that your application dated December 11, 2009, contained many pages of extraneous documents that were not necessary to process the change of ownership/control amendment. Typically, only the Form NRC 313 and the responses to NUREG 1556, Vol. 15, Appendix F are required to process a change of ownership/control amendment, unless other changes affecting the license will take place concurrently, such as changes in personnel, authorized materials, etc.**

The enclosed document contains sensitive security-related information.  
When separated from this cover letter this letter is uncontrolled.

**Please note that, at this time we updated your license to include a new Condition No. 23. This change should enhance your awareness of regulatory requirements associated with possession limits as they apply to decommissioning of your facility.**

NRC's Regulatory Issue Summary (RIS) 2005-31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS, the NRC's electronic document system.

Pursuant to NRC's RIS 2005-31 and in accordance with 10 CFR 2.390, the enclosed license document is exempt from public disclosure because its disclosure to unauthorized individuals could present a security vulnerability.


