Dear Mr. Bermudez:

This letter is to notify that a newly created affiliated entity of the group of hospitals known as Metro Pavia will acquire Hospital Dr. Pila in Ponce, Puerto Rico.

This new entity that will purchase the hospital is Metro Ponce, Inc. [EIN 660-714531]. This transaction is subject to the approval of the US Bankruptcy Court (Hospital Dr. Pila is currently in a Chapter 11 proceeding) and the Housing and Urban Development Administration (HUD) which is the mortgage holder.

As a result, the specific closing date is uncertain, but should happen on or before the end of May 2010.

The transaction is an asset purchase in which Fundacion Dr. Pila Iglesias, Inc. is seller and Metro Ponce, Inc. is the buyer. The main shareholder of Metro Ponce, Inc., is Eduardo Artau Gómez, MHA (social security no. \_\_\_\_\_), who also owns the other eleven Metro Pavia hospitals. The contact is the undersigned.

As of present, we don't foresee any changes in personnel or in organization, location, facilities, equipment or procedures involving the materials license.
