FOR THE RENEWAL OF OPERATING LICENSES FOR
DIABLO CANYON NUCLEAR POWER PLANT, UNITS 1 AND 2
AND OPPORTUNITY FOR A HEARING,
DOCKET NOS. 50-275-LR AND 50-323-LR

The Office of the Secretary has received a petition to intervene and notice of appearance submitted by Diane Curran, representing San Luis Obispo Mothers for Peace (SLOMFP). The petition to intervene dated March 22, 2010, was submitted via e-filing. The petition was filed in response to a notice issued by the NRC staff which provided an opportunity for hearing with respect to an application for the renewal of operating license Nos. DRP-80 and DPR-82 for an additional 20 year period for the Pacific Gas & Electric Company, Diablo Canyon Nuclear Power Plant, Units 1 and 2, Docket Nos. 50-275-LR and 50-323-LR. The notice was published in the *Federal Register* at 75 Fed. Reg. 3493 (January 21, 2010).

In addition to the petition to intervene, the intervenor submitted by e-filing on March 22, 2010, a petition for waiver of 10 C.F.R. Part 51 Subpart A Appendix B and 10 C.F.R. § 51.53(C)(2).

The petitions and the notice of appearance are located in ADAMS as package (ML100810439). The accession numbers for the documents in the package are listed separately as the petition to intervene (ML100810441), the petition for waiver (ML100810442), and the notice of appearance by Diane Curran (ML100810440). All of the documents can also be found on the Electronic Hearing Docket (EHD).

The petition to intervene and the petition for waiver are being referred to you for appropriate action in accordance with 10 CFR §2.346(i). This referral is being served on the service list for Diablo Canyon License Renewal via the e-submission form and on the individuals included in the cc list.
