The purpose of this modification is to extend the period of performance from 12/04/2009 to 01/12/2010 at no additional cost to the Government. Verizon was not instrumental in releasing the phone number porting, as a result Verizon continued services to the NRC Region II location. Therefore the period of performance extension allows for these services to be paid. Accordingly the contract is modified as follows:

(1) Refer to Section B.5, entitled "DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 4 (JUN 1988)", is deleted in its entirety are replaced with the following:

"The ordering period for this contract shall commence on October 1, 2004 and will expire on January 12, 2010. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering.)"

All other terms and conditions remain unchanged including the contract ceiling of \$235,495.00.
