SUBJECT: SUMMARY OF THE MARCH 31, 2010, PUBLIC MEETING TO DISCUSS
FENOC FLEET PERFORMANCE

On March 31, 2010, the Nuclear Regulatory Commission (NRC) Headquarters, Region I and Region III met with the FirstEnergy Nuclear Operating Company (FENOC) management to discuss fleet performance. The public meeting was held at the Embassy Suites, Pittsburgh International Airport. The meeting notice, licensee presentation and list of attendees can be found in the Agencywide Documents Access and Management System (ADAMS) as ML100600637, ML100910266 and ML100910315, respectively. A list of principal NRC and licensee meeting participants is enclosed.

The NRC began the meeting with a brief introduction, followed by FENOC management discussions of 2009 fleet performance, individual site overviews for Beaver Valley, Perry and Davis-Besse, fleet oversight and assessment updates and fleet project updates. At the end of the meeting, members of the public were given the opportunity to ask questions of NRC officials.

The meeting provided a useful forum to discuss common themes at the FENOC plants with the NRC Regions I and III, the Office of Nuclear Reactor Regulation and the Office of Nuclear Security and Incident Response. The meeting concluded with a discussion of plans to continue annual meetings involving the NRC regions and program offices and all plants in the FENOC fleet.
