SUBJECT: VOGTLE ELECTRIC GENERATING PLANT UNITS 3 AND 4 –
COMBINED LICENSE APPLICATION - ADVANCED SAFETY
EVALUATION WITHOUT OPEN ITEMS FOR CHAPTER 3, "DESIGN
OF STRUCTURES, COMPONENTS, EQUIPMENT, AND SYSTEMS"

By letter dated March 28, 2008 (ML081050133), Southern Nuclear Operating Company (SNC) submitted an application to the U.S. Nuclear Regulatory Commission (NRC) for a combined license (COL) for Vogtle Electric Generating Plant (VEGP), Units 3 and 4.

Based on our review of the application, the staff is providing the Advisory Committee on Reactor Safeguards (ACRS) its Advanced Safety Evaluation (ASE), with Open Items for Chapter 3, "Design of Structures, Components, Equipment, and Systems" (ML093210002). Unless otherwise stated in the SE, the staff's review was based on Revision 2 of the application. The SE is being provided to support a meeting of the subcommittee of the ACRS scheduled for December 2010. The ACRS Full Committee meeting will be held after the subcommittee meeting.

The staff has reviewed the ASE and found no topics that meet the categories of interest that ACRS members would like to review in detail.

The staff concludes that the ASE does not contain any information exempt from public disclosure. However, the NRC will withhold the ASE from public disclosure for ten business days to allow SNC the opportunity to verify the staff's conclusion that the ASE contains no such exempt information. Therefore, the staff requests that the ACRS withhold the ASE from public disclosure until it has been released publicly in the Agencywide Documents Access and Management System.

The staff will inform the ACRS immediately if SNC requests that any of the information in the ASE be withheld from public disclosure.
