Duratek Services (a subsidiary of EnergySolutions) is submitting this notification to export radioactive equipment from our Memphis, Tennessee facility to Canada.

The purpose of this notification is to return a refurbished radioactive contaminated pump impeller and associated equipment to the owner, Ontario Power Generation's Pickering Station.

The Memphis facility is contracted by FlowServe, Inc. to provide licensed support services for equipment refurbishing work performed by FlowServe, Inc. The equipment was imported from Canada under the general import license provisions of 10 CFR 110.27 and will be returned under the general export license provisions of 10 CFR 110.26.
