Wireless Communications Technology in the Nuclear Industry Meeting

On March 25, 2010, the staff participated in a meeting to discuss the use of wireless communications technology in the nuclear industry at the Congressional Visitors Center in Washington, DC. Several industries and government agencies were represented at the meeting. National Aeronautics and Space Administration and U.S. Department of Energy Savannah River project representatives made presentations on projects that have been implemented using this technology. General Electric also reported on a pilot project that used wireless technology in a turbine control system implementation. Though no applications have yet been received by the NRC for safety related applications using wireless technology, it is evident that the technology has advanced significantly in recent years and is now being implemented in several safety significant systems. The Office of Research currently has plans to develop guidance in this area in anticipation of future use of this technology.

The amendment request is expected to be submitted by September 2010. The application schedule for the MAGNATRAN package is still uncertain.

Training Provided to Texas Staff and Utah Staff on Screening Analysis

On March 25-26, 2010, NRC staff conducted a meeting with staff from the Texas Commission on Environmental Quality and the Utah Division of Radiation Control in Austin, Texas, regarding the screening analysis described in Commission Paper SECY-08-0147 for disposal of significant quantities of depleted uranium. Staff described the modeling approaches used in the screening analysis and discussed modeling approaches using the GoldSim computer code for assessing the performance of a low-level radioactive waste disposal site.

Interagency Committee on Standards Policy (ICSP) Meeting

On March 24, 2010, the ICSP held a quarterly meeting attended by the NRC Standards Executive and a RES staff member. ICSP members summarized recent coordination on such topics as smart electrical grid standards, health care information technology, and nuclear energy-related standards. The ICSP chairperson announced formation of a new Subcommittee on Standards under the National Science and Technology Council's Committee on Technology to be co-chaired by the National Institute of Standards and Technology and the U.S. Department of Justice. The Subcommittee on Standards will provide direction and guidance to the ICSP and will rely on the ICSP to coordinate interagency implementation of standards policy, assess progress, and develop potential policy options or guidance with the goal of removing barriers to effective standards development or use.

Office of Management and Budget Meeting on Open Government Plans

On March 31, 2010, staff participated in an Office of Management and Budget (OMB) cross agency Open Government Working Group meeting. The meeting was hosted by Cass Sunstein, Administrator, OMB's Office of Information and Regulatory Affairs. In addition to Federal agency representation, open government advocate groups, such as OMB Watch and the Sunshine Foundation participated. The objective of the meeting was to provide agencies additional feedback on reviews of agency draft open government plans by the open advocate groups as well as allowing OMB to provide additional guidance to agencies prior to the April 7, 2010, date by which all agency plans will be published. OMB had previously provided agencies copies of the U.S. Department of Health and Human Service's and NRC's draft plans as plans OMB felt had done a good job of achieving the intent of OMB's Directive on open government with regard to agency Open Government Plans.
