In order for material to be removed from the license, a licensee should provide documentation that another licensee has accepted the material. Please provide evidence that the "Oncology Hospital" received the linear accelerator and that the hospital was licensed for this material. Please provide the legal name of the "Oncology Hospital" and the hospital's address.
