Please accept this letter as notice of an impending transaction ("Transaction") whereby the parent corporation of Saint Alphonsus Regional Medical Center ("SARMC"), an Idaho nonprofit corporation and Nuclear Regulatory Commission licensee, will change from ~~Trinity Health Corporation~~ to ~~Trinity Health Oregon-Idaho, Inc.~~ an Idaho nonprofit corporation and subsidiary of Trinity Health Corporation ("Trinity"). The Transaction is part of the creation of a new Trinity-operated regional healthcare system in the Eastern Oregon/Western Idaho region.

SARMC is licensed to operate 387 acute care hospital beds in Boise, Idaho. SARMC will remain the licensee of the hospital after the Transaction takes effect. Additionally, SARMC will operate under the same federal tax identification number before and after the Transaction. Thus, ~~the only change~~ resulting from the Transaction will be for Trinity to become the parent corporation of SARMC in place of Trinity Health Corporation.

The effective date of the Transaction will be on ~~April 1, 2010~~. Please accept this letter as a request on behalf of SARMC for the Nuclear Regulatory Commission's consent to transfer SARMC's NRC materials license (the "License").

No changes to the organization, location, facilities, equipment or procedures that relate to SARMC's activities under the License are anticipated at this time. In addition, Trinity will not change the personnel and duties in relation to the use of nuclear materials and will not add new personnel as a result of the Transaction. The facility will not be decommissioned as a result of the Transaction.

The current status of the surveillance program is consistent with previous filings. The surveillance program is anticipated to continue in the same manner at the time of transfer, in accordance with NRC requirements.

Trinity is aware of and will abide by all constraints, conditions, requirements and commitments of SARMC with respect to the License. Furthermore, Trinity will request an amendment of the License to reflect this Transaction immediately after the effective date of the Transaction. Trinity's President and






