By letter dated September 20, 2007, STP Nuclear Operating Company (STP) submitted for approval a combined license application pursuant to 10 CFR Part 52. The U. S. Nuclear Regulatory Commission (NRC) staff is performing a detailed review of this application to enable the staff to reach a conclusion on the safety of the proposed application.

The NRC staff has identified that additional information is needed to continue portions of the review. The staff's request for additional information (RAI) is contained in the enclosure to this letter.

To support the review schedule, you are requested to respond within 30 days of the date of this letter. If changes are needed to the safety analysis report, the staff requests that the RAI response include the proposed wording changes.

Section 7.6 of the STP 3 & 4 Tier 2 COL application states that Table 7.6-5 and Figure 7.6-2 are impacted by Tier 1 departure STD DEP T1 2.2-1. According to the Departure Report in Part 7 of the application, this departure is associated with testing of the uninterruptible power supplies for redundant RCIS controller equipment, and only impacts Tier 1 Section 2.2, and Tier 2 Section 7.7. The staff is unable to determine any correlation between this departure STD DEP T1 2.2-1 and the stated parts of Tier 2 Section 7.6. The applicant is asked to resolve this discrepancy and provide the departure(s) that impact Table 7.6-5 and Figure 7.6-2.
