ADDITIONAL TERMS AND CONDITIONS FOR PRESENT AND SEPARATED NRC

1. THE NRC WILL SEND ONLY ONE WRITTEN DEMAND (*i.e.*, INVOICE) TO A DEBTOR WHO IS A CURRENT NRC EMPLOYEE.
2. PAYMENT OF THE AMOUNT SHOWN ON THIS INVOICE MUST BE RECEIVED PRIOR TO TERMINATION OF EMPLOYMENT BY THE NRC OR BY SUCH EARLIER DATE AS MAY HAVE BEEN SPECIFIED IN THIS INVOICE.
3. IF PAYMENT CANNOT BE MADE IN ONE LUMP SUM IN ACCORDANCE WITH THE TERMS AND CONDITIONS ON THE INVOICE, EFFORTS WILL BE MADE TO COLLECT BY ADMINISTRATIVE OFFSET OR SALARY OFFSET (*administrative offset without employee consent*) IN SPECIFIC AMOUNTS AGAINST:
 - a. the employee's current or final paycheck commencing in pay period _____,
 - b. any excess amount that has been withheld for income tax purposes, and
 - c. any amount payable to the employee from the Civil Service Retirement and Disability Fund upon termination of employment.

NOTICE OF DUE PROCESS RIGHTS FOR PRESENT AND SEPARATED NRC EMPLOYEES

AN EMPLOYEE HAS THE RIGHT TO:

1. RECEIVE WRITTEN DEMAND FOR PAYMENT AND TO BE INFORMED OF THESE RIGHTS;
2. AGREE WITH NRC IN WRITING TO REPAY THE DEBT IN INSTALLMENTS IF PAYMENT CANNOT BE MADE IN ONE LUMP SUM IN ACCORDANCE WITH THE TERMS AND CONDITIONS ON THE INVOICE;
3. DISPUTE THE AMOUNT OR VALIDITY OF THE DEBT IN WRITING WITHIN 10 WORKING DAYS AFTER THE INVOICE DATE (*must be supported by statements of the employee's contentions and supporting documentation*);
4. REQUEST A WAIVER OF THE DEBT UNDER 5. U.S.C. 5584 IF THE DEBT INVOLVES ERRONEOUS PAYMENT OF PAY OR ALLOWANCES (*travel and transportation expenses and allowances and relocation expenses are not subject to waiver*);
5. REQUEST A PRE-OFFSET HEARING IF ISSUES OF CREDIBILITY OR VERACITY ARISE DURING A REQUEST FOR RECONSIDERATION OR WAIVER AND CANNOT BE RESOLVED BY THE DOCUMENTARY EVIDENCE AVAILABLE (*NRC has the right to conduct a hearing AFTER the administrative offset is taken, if the time prior to termination does not permit a pre-offset hearing*);
6. INSPECT AND COPY RECORDS RELATING TO THE AMOUNT DUE WITHIN 10 WORKING DAYS AFTER THE INVOICE DATE; AND
7. SUBMIT THE MATTER TO THE COMPTROLLER GENERAL OF THE UNITED STATES FOR A DECISION IF EMPLOYEE DIFFERENCES CANNOT BE RESOLVED WITHIN THE NRC.

IF AN EMPLOYEE FAILS TO RESPOND TO AT LEAST ONE OF THE FOLLOWING STATEMENTS, NRC WILL MAKE THE ADMINISTRATIVE OFFSET BASED UPON ITS KNOWLEDGE OF THE DEBT. IF THE EMPLOYEE RESPONDS TO ONE OR MORE OF THE FOLLOWING STATEMENTS, THE RESPONSE(S) WILL BE TAKEN INTO CONSIDERATION. (*Please remove and reverse the carbon so that information to be provided in remarks will also appear on the copy.*)
