Background

Cintichem, Inc., letter of October 31, 1986, transmitted a revision to the Physical Security Plan for the Cintichem, Inc. facility at Tuxedo, New York. This revision resulted from Inspection Nos. 86-01 and 86-02. The changes, and evaluation of their acceptability under 10 CFR 70.32(e) and 50.54(p), are presented below.

Changes and Evaluation

All changes were reviewed and are considered to be acceptable as follows:

Cover Sheet of Physical Security Plan - Due to the recent change of ownership, the facility name was changed from Union Carbide Corporation to Cintichem, Inc.

Figure 4-1 - The Organizational Chart was revised to reflect job title changes. The title of Union Carbide Business Manager - Radiochemicals was changed to Cintichem, Inc. Plant Manager. The title of Manager, Health, Safety and Environmental Affairs was changed to Manager, Site Operations. This position now assumes the responsibility as Site Security Officer (SSO). The SSO responsibility was previously assigned to the Manager, Maintenance & Engineering.

Pages 2.2 and 3.6; Sections 2.2 and 3.6 - References to the "receptionist's office in Building 2" were deleted since the position was eliminated and alternate controls are in place.

Page 3.4; Section 3.3 - The title of Business Manager, Radiochemicals was changed to Plant Manager.

Page 4.1; Section 4.2 - The responsibilities of the Site Security Officer were transferred from the Manager of Engineering and Maintenance to the Manager of Site Operations. An editorial change was also made on this page.




