As we discussed by telephone, it is our understanding that Dr. John L. Bormann (Radiation Safety Officer) can sign for Sturgis Hospital, Inc. (transferee), however, we need documentation from the transferor (Sturgis Hospital) that they agree to the change in ownership or control of the licensed material and activity and the conditions of transfer.


Possession Limit for 10 CFR 35.300 Materials

Please specify a maximum possession limit for iodine-131 that you may use under 10 CFR 35.300. As we discussed, in accordance with 10 CFR 30.32 (i) (1), possessing over 10 Curies of iodine-131 may require an evaluation of the dose to a person offsite due to a release of radioactive materials or an Emergency Plan.
