SUBJECT: REQUEST FOR COMMENTS ON THE DRAFT ENVIRONMENTAL IMPACT  
STATEMENT FOR THE VIRGIL C. SUMMER NUCLEAR STATION, UNITS 2  
AND 3, COMBINED LICENSE APPLICATION REVIEW

Dear Mr. Grieve:

The U.S. Nuclear Regulatory Commission (NRC) staff is reviewing an application submitted by the South Carolina Electric and Gas Company (SCE&G) acting for itself and as an agent for South Carolina Public Service Authority (also referred to as Santee Cooper) for two combined licenses (COLs) to construct and operate two new nuclear power units at its Virgil C. Summer Nuclear Station, Units 2 and 3 (VCSNS), site in Fairfield County, South Carolina. As part of the review of the proposed actions, the NRC staff has prepared a draft environmental impact statement (DEIS). The U.S. Army Corps of Engineers, Charleston District (USACE), is a cooperating agency on the DEIS. The DEIS includes analyses of relevant environmental issues, and documents the NRC and USACE staff's determination regarding the suitability of the proposed site for the construction and operation of two new nuclear power units.

Please provide any information, comments, or concerns you may have on the DEIS during the comment period, which ends on July 6, 2010. Comments should be submitted either by mail to the Chief, Rules, Announcements, and Directives Branch, Division of Administrative Services, Office of Administration, Mailstop TWB-05-B01M, U.S. Nuclear Regulatory Commission, Washington, D.C. 20555-0001 or by e-mail to [Summer.COLEIS@nrc.gov](mailto:Summer.COLEIS@nrc.gov).

The first meeting will convene at 12:00 p.m. and will continue until 4:00 p.m., as necessary. The second meeting will convene at 6:00 p.m. and will continue until 10:00 p.m., as necessary.
